

*Into the Wild* Mini Oral Presentation Miss Dictor IB English 11 2007 – 2008

## Assignment:

Develop and present an oral presentation of 5 - 10 minutes in length that analyzes several key aspects of a chapter of *Into the Wild*. You must use specific textual evidence to support your claims, explain your rationale effectively and analyze the author's purpose in this chapter as well as how effectively he achieves this purpose.

## Procedure:

- 1. Choose one chapter of Into the Wild.
- 2. Determine the author's purpose in this chapter.
- 3. Analyze AT LEAST 2 of the following aspects:
  - the significance of the opening excerpt(s) from outside text(s)
  - how nature functions as a "character" in the chapter
  - how Krakauer uses people other than Chris to achieve his purpose in this chapter
  - how Krakauer establishes the parallels between himself and Chris McCandless in the chapter
- 4. Use AT LEAST 5 specific pieces of evidence from the chapter.
- 5. Explain how your evidence supports your claims.
- 6. Before you present, you must give Miss Dictor a typed piece of paper that includes a complete heading, the chapter you are analyzing, which bullets you will be discussing and the specific textual evidence, including page numbers, that you will be using in your presentation. Failure to do so will lower your grade.

## <u>Grading:</u>

- I will use the IB scoring rubric on the back of this sheet to score your presentation. This is the same rubric that will be used to score the formal oral presentations you will be presenting later this year.
- Your peers will also be evaluating your presentation on another form. My score will count as a major grade, and your peer's scores will also count as a minor grade.

We may not finish all orals that day, but I will be calling you at random, so you MUST be prepared to present that day or it will be considered a late major assignment and the best makeup grade you will receive is an 80%.
