After consideration on the merits, the Committee recommends the following:

HB03-1108 be amended as follows:

1 Amend the proposed committee amendment (HB 1108_L.005), page 3,
2 strike lines 1 through 13 and substitute the following:

3 "PUBLIC IN AN ELECTRONIC FORMAT.

4 (c) EACH GOVERNING BOARD SHALL SET THE NUMBER OF CREDITS
5 THE INSTITUTION MAY GRANT TO A STUDENT WHO HAS SUCCESSFULLY
6 COMPLETED AN INTERNATIONAL BACCALAUREATE DIPLOMA PROGRAM;
7 EXCEPT THAT THE NUMBER OF CREDITS GRANTED, AT A MINIMUM, SHALL
8 BE TWENTY-FOUR SEMESTER CREDITS OR THEIR EQUIVALENT. EACH
9 GOVERNING BOARD SHALL IDENTIFY THE SPECIFIC GENERAL EDUCATION OR
10 ELECTIVE REQUIREMENTS THAT THE STUDENT SATISFIES BY HAVING
11 SUCCESSFULLY COMPLETED THE INTERNATIONAL BACCALAUREATE
12 DIPLOMA PROGRAM AND SHALL OUTLINE THE CONDITIONS NECESSARY TO
13 AWARD THE CREDITS.

14 (d) NOTWITHSTANDING THE PROVISIONS OF PARAGRAPH (c) OF THIS
15 SUBSECTION (2) TO THE CONTRARY, EACH INSTITUTION MAY DETERMINE
16 THE LEVEL OF STUDENT PERFORMANCE NECESSARY TO GRANT THE
17 CREDITS, AS MEASURED BY A STUDENT'S EXAM PERFORMANCE IN THE
18 SPECIFIC COURSES CONSTITUTING THE INTERNATIONAL BACCALAUREATE
19 DIPLOMA PROGRAM; EXCEPT THAT THE STUDENT SHALL RECEIVE AT LEAST
20 A SCORE OF FOUR ON AN EXAM TO BE GRANTED THE CORRESPONDING

2 (3) THE PROVISIONS OF THIS SECTION SHALL NOT APPLY TO ANY
3 INSTITUTION OF HIGHER EDUCATION THAT HAS ENTERED INTO A
4 PERFORMANCE CONTRACT WITH THE COMMISSION AS AN EXEMPLARY
5 INSTITUTION OF HIGHER EDUCATION."
